Some homeowners need to work on areas that don't have enough gravel in their back yard which cases their dirt into the street. Also one of the homes that have just had rock installed still has their sand bags at their front door – Melinda Ford will contact homeowner to ask to have them removed.

Clean and Safe Committee – nothing to report. Susan Klement is working on an updated map and homeowner contact information directory.

Landscape Committee – Shirley reported that trees have been trimmed and one Palo Verde had to be removed. McColley Smith spent a few days mitigating water leaks. In the spring we will be adding trees along the wall.
